Pursuant to Article IV, Part 2, § (12) of the Arizona Constitution and A.R.S. §38-431.02, notice is hereby given to the Commissioners of the Arizona Independent Redistricting Commission and the general public that the Arizona Independent Redistricting Commission will hold a regular meeting open to the public on November 3, 2001, beginning at 10:00 a.m. at the Embassy Suite Hotel, 1515 N. 44<sup>th</sup> Street, Phoenix, Arizona in the Turquoise Room on the 3<sup>rd</sup> Floor.

The Commission may vote to go into executive session, which will not be open to the public, for any item listed on the agenda, for the purpose of discussing personnel matters (A.R.S. §38-431.03(A)(1)), consulting with Commission attorneys, regarding pending or contemplated litigation (A.R.S. §38-431.03(A)(4)), or obtaining legal advice (A.R.S. §38-431.03(A)(3)).

The agenda is as follows:

- I. Call to Order.
- II. Public Comment.

This is the time for consideration and discussion of comments and complaints from the public. Those wishing to address the Commission shall request permission in advance by filling out a speaker slip. Action taken as a result of public comment will be limited to directing staff to study the matter or rescheduling the matter for

further consideration and decision at a later date unless it is the subject of an item already on the agenda.

- III. The Commission may vote to go into an Executive session that is not open to the public for the purpose of discussion or consultation for legal advice with the Commission's attorneys pursuant to A.R.S. §38-431.03(A)(3) and for the purpose of discussion or consultation with the Commission's attorneys in order to consider its position and instruct its attorneys regarding the Commission's position in pending or contemplated litigation pursuant to A.R.S. §38-431.03(A)(4).
- IV. Presentation by NDC and/or legal counsel, discussion and possible decision(s) concerning public input received following the October 14, 2001, adoption of the final congressional and legislative drafts subject to further action of the Commission.
- V. Presentation by NDC, discussion and possible decision(s) concerning
  - A. Possible changes to the final congressional plan for population balancing;
  - B. Possible changes to the final legislative plan for neighborhood clean-up; and
  - C. Possible adjustments to final legislative lines to prevent small populations trapped between congressional and legislative lines.
- VI. Presentation by legal counsel, discussion and possible decision(s) concerning additional record of Commission findings.
- VII. Presentation, discussion and possible decision(s) concerning amendment of the Commission's budget.
- VIII. Certification of the final congressional and legislative districts to the Secretary of State.
- IX. Discussion of future Commission Meeting(s).
- X. Public Comment. (Same guidelines as stated in agenda item II).
- XI. Possible statements by Commissioners, Executive Director, Consultants and/or Legal Counsel.
- XII. Recess or Adjournment.
