Possible report(s), presentation(s), discussion(s) and decisions concerning instructions to NDC as to the testing of possible alternatives to the proposed draft district configurations for compliance with the Proposition 106 criteria, including but not limited to, compliance with the Voting Rights Act and consideration of district competitiveness
- VI. Future Commission Meeting(s).
- VII. Adjournment.

The Commission may vote to go into executive session, which will not be open to the public, for any item listed on the agenda, for the purpose of discussing personnel matters (A.R.S. §38-431.03(A)(1)), consulting with Commission attorneys, regarding pending or contemplated litigation (A.R.S. §38-431.03(A)(4)), or obtaining legal advice (A.R.S. §38-431.03(A)(3)).
