10	(Whereupon, the public session commenced.)
11	CHAIRPERSON MATHIS: This meeting of the Arizona
12	Independent Redistricting Commission will now come to order.
13	I'd like everyone to please rise, and we'll say
14	the Pledge of Allegiance.
15	(Whereupon, the Pledge of Allegiance commenced.)
16	CHAIRPERSON MATHIS: Now that we're all awake, I'd
17	like to inform everyone who would like to speak during
18	public comment session to please fill out a request to speak
19	form and give that to our executive director, Ray Bladine.
20	I have a number of them here today, so we'll be
21	getting to that shortly on the agenda.
22	I'd also like to note we have a court reporter
23	transcribing this meeting for us, Marty. And so everyone
24	please be aware of that. And when you come up for public
25	comment please state your name and the organization you're

1	representing and what issue you'd like to talk about so that
2	we have a clear record taken.
3	And also I remind the commissioners to not speak
4	over one another, one at a time so that we can have an
5	accurate record too.
6	RAY BLADINE: I don't think your mic is on.
7	CHAIRPERSON MATHIS: Okay.
8	So if we could begin with roll call.
9	Vice Chair Freeman?
10	VICE CHAIR FREEMAN: Here.
11	CHAIRPERSON MATHIS: Vice Chair Herrera?
12	VICE CHAIR HERRERA: Here.
13	CHAIRPERSON MATHIS: Commissioner McNulty?
14	COMMISSIONER McNULTY: Here.
15	CHAIRPERSON MATHIS: Commissioner Stertz?
16	COMMISSIONER STERTZ: Here.
17	CHAIRPERSON MATHIS: And this is somewhat of an
18	auspicious occasion. This is the first time that our
19	commission is actually all present together with legal
20	counsel.
21	And I'd like to acknowledge them.
22	We have two individuals with long track records of
23	public service to our state. Joe Kanefield, who was just
24	recently Governor Brewer's counsel, is now in private
25	practice. And Mary O'Grady, who was former solicitor

1 general for the state. 2. And we also have Executive Director Ray Bladine 3 here. 4 And I thank our staff for organizing this and 5 getting this all set up and Buck for getting us streaming. 6 And he's over there with earphones on, so we're 7 all set. 8 And I'd also like to thank the Town of Oro Valley 9 for hosting us today. This is a very fancy venue for us 10 frankly compared to other locations, not to, you know, 11 offend anyone, but this is very nice. And I thank the League of Arizona Cities and Towns 12 13 who I think put us in touch with the Town of Oro Valley. 14 thank you. 15 And thanks to all of you for being here today. 16 Let's start with agenda item two. That's call for public comment, which we do at each of our meetings. 17 And this is the time to address the Commission, 18 19 and we'll receive your public input. 20 And given that we have so many slips today, which 21 is great, we're going to ask that you limit your time to 2.2 four minutes per person, if that's adequate, and I am hoping 23 that would be. 24 And we'll start with the first one I have here, 25 Kevin Burke, who's from the Town of Oro Valley and his

1 subject is greeting. 2. MR. KEVIN BURKE: Chair Mathis, members of the Commission, my name is Kevin Burke, assistant to the town 3 4 manager here in Oro Valley. I wanted to welcome you to our 5 town and welcome you to District 26. 6 I want to just say we really appreciate you taking 7 the opportunity to come down and spread the message about 8 what you're doing with the AIRC and your work throughout the 9 state of Arizona. We're glad that you're here in the town 10 of Arizona(sic). You'll find we have a very active and 11 engaged citizenry, so good luck today. Thank you very much. 12 CHAIRPERSON MATHIS: Thank you. Thanks for having 13 us. 14 Our next speaker is Ralph Kayser, representing 15 Tucson Tea Party. And the subject is communities of 16 interest. 17 If I mispronounce anyone's name, please correct 18 me --19 MR. RALPH KAYSER: You got it right. Thank you. 20 Good morning, ladies and gentlemen of the 21 Commission. My name is Ralph Kayser. I'm a resident of 22 Oro Valley and a small business owner in Tucson. I'm also a 23 member and one of the principal organizers of the Tucson Tea 24 Party. 25 I'm here representing the Tucson Tea Party, a

1 group of approximately 3500 members. We're nonpartisan in that our membership consists of freedom loving individuals 2. from all political parties. 3 4 I'd like to speak to the importance of using the concept of keeping communities of like interest together as 5 6 a key element of your redistricting criteria, and we'll use 7 the following example. 8 Many of our Tea Party members live in the 9 Saddlebrook community, 27 miles north of Tucson. 10 That community currently is part of State 11 Legislative District 26 and U.S. Congressional District 8. 12 The Saddlebrook community is closely tied to 13 Tucson, Oro Valley, and Marana in terms of church 14 affiliation, social groups, business ties, political 15 interest groups including the Tucson Tea Party. We eat at 16 the same restaurants, shop in the same major retail 17 locations, attend the same churches. Saddlebrook is a closely linked in a community of 18 interest with other cities in communities in the Tucson 19 20 area. 21 Geographic proximity and ease of transit within 2.2 these communities of like interest are integral to the 23 linkages that bind the Saddlebrook community to the larger 24 Tucson community. 25 The Saddlebrook community on the other hand is

1 73 miles from the next largest community in Pinal County and 2. Legislative District 23, Casa Grande. 3 And shares very little with this community in 4 terms of common interests. 5 It would be unnecessary and highly irregular to 6 consider changing the legislative boundaries to isolate and 7 exclude the Saddlebrook community from other communities in 8 the northwest Tucson area. 9 In terms of drawing new Legislative and 10 Congressional district boundaries, we would urge you not to 11 do this. 12 CHAIRPERSON MATHIS: Thank you. 13 Our next speaker is Onita Davis from Tucson Smart 14 Girl Politics, and the subject is mapping. 15 MS. ONITA DAVIS: Good morning. My name is Onita 16 Davis, and I am an Independent. I belong to Smart Girl 17 Politics, which is a nonpartisan organization to encourage 18 women to participate in politics. 19 We Independents have tried to do your job for you. 20 We have created a redistricting map for southern 21 Arizona. 2.2 In doing so, we took into consideration the 23 five reasons for redrawing lines for redistricting 2011. 24 It is our belief that the lines do not have to be 25 drastically changed to, one, create equal populations. The

shift in population can be adequately addressed by minor redrawing of the lines. Such minor modifications would allow communities of like interest to continue to exist. To create compact and continuous communities because in most instances that exists today.

2.

For example, we have many small independent communities in northwest Pima County that positively coexist due to commonality of interest.

For example, Saddlebrook, Eagle Crest, Catalina, Oro Valley. And I'm a resident of Oro Valley. Adjacent unincorporated areas and Marana form a very strong continuous -- contiguous community of like interest.

Does not have to be drastically changed to respect local boundaries, because the term boundaries goes beyond just city or county, but includes many aspects of our lives, such as schools or economic and culture centers.

Does not have to be drastically changed to create competitiveness, because how do you proscribe such a thing when the number of Independents has outpaced Democrats and may overtake Republicans.

Does not have to be drastically changed to keep communities of like interest together, which is the most important criteria, at least as far as I'm concerned.

We want to be grouped with other communities with which we share hospitals, schools, shopping, medical

1	facilities, economic development, and cultural interest.
2	Each of us has a vested interest in the success of
3	the other.
4	In fact, as my community of interest exists today,
5	it fits the description given for communities of like
6	interest on your website, which includes religion, political
7	ties, history, tradition, geography, demography, ethnicity,
8	culture, social and economic status, trade, or other common
9	interests that would benefit from common representation.
10	We believe our map does all of this, and does them
11	very well, thank you.
12	A copy of the map is being provided because, if
13	you are like me, it helps to have a visual aid.
14	We hope you'll take these factors into
15	consideration in your study. Thank you.
16	CHAIRPERSON MATHIS: Thank you.
17	Our next speaker is Scott Leska. He is
18	representing PC361, and the subject is mapping redistrict
19	boundaries.
20	MR. SCOTT LESKA: Good morning. My name is Scott
21	Leska, as you mentioned. I'm a resident of Oro Valley.
22	And I am not going to be as articulate as Onita.
23	She is very articulate. Same like minded type of person as
24	me though, as she presented.
25	Eagle Crest, Oro Valley, Catalina, Saddlebrook,

1	northwest Tucson really have the same like minds as
2	politically, economically, culturally. Ninety percent of my
3	friends live up in this side of town. My church is in this
4	side of town. I work at this side of town. I work in the,
5	you know, in the northwest.
6	And I do not want redistricting lines to change.
7	I like this I like the political climate here.
8	I love Oro Valley, and I think and I'm hoping that you will
9	take my consideration, as well as the others that are
10	possibly going to speak here, into really deep hearted
11	consideration to keep our constituent base the way it is
12	now.
13	Or LD 26 the way it is. Marana. Marana has the
14	same like minded as northwest Tucson region.
15	So I really hope and pray that you all take this
16	into heart, that we do not want the boundaries to change.
17	At least keep it as close as possible as it is
18	today. Thank you.
19	CHAIRPERSON MATHIS: Thank you.
20	Our next speaker is Jeff Anderson, representing
21	Legislative District 25, and his subject is public access
22	electronic communication web presence and open meeting law.
23	MR. JEFF ANDERSON: Good morning. Thank you for
24	allowing me the opportunity to speak.
25	I won't be I'll be well within my time limit.

1 I would like to bring to your attention 2 three items that concern me when -- as I try to get involved in looking at redistricting and doing my civil duty. 3 4 I'd like on the topic of open meeting law to bring 5 to your attention that the Arizona statutes specifically 6 excludes Sunday from the days on which you can conduct your 7 business. 8 And I would like to point out that by issuing a 9 meeting notice on Sunday could be construed as violating 10 that regulation as it specifically does not allow you the 11 ability to do that. It also should be noted that the complex nature of 12 13 the subject at hand, redistricting, does not lend itself 14 well to short notice preparation such as the 24-hour rule 15 specified in the statute. 16 Thank you for the 48 hours that you granted us. However, due to the complexity of this, I think 17 18 that it doesn't support the due process of the citizenry as 19 it doesn't give us much opportunity to put together a 20 cohesive argument or suggestion or opinion. 21 Because of that, I would request that this meeting 2.2 be rescheduled to a later date. 23 Next, on the agenda I would like to bring to your 24 attention deceptive web presence. 25 I would like to let you know that the

1 ArizonaRedistricting.com website is deceptively published on 2. the Internet such that the site does not allow people to gain access through the use of non-functioning links. 3 4 This practice has been published on the Internet 5 by several individuals, one Warren Smith of RangeVoting.org. 6 As much as three weeks ago, apparently the Arizona 7 Redistricting.com site has a second access check that allows 8 it to be able to use the full functions of the website. 9 specifically the mapping program. 10 Lastly, public access of electronic communication, 11 I would like to suggest that the executive sessions be open 12 to public viewing, of any and all electronic meetings such 13 as those conducted with the Skype interface to include the 14 executive sessions. 15 And I would simply close with one last request, 16 that you do not use a 60/40 rule in determining redistricting lines. Specifically one side I've seen in 17 some conversations on the subject of redistricting that 18 19 people consider a 60/40 rule Democratic over Republican to 20 be fair, but the reverse is not fair. So I would ask that you not consider it at all. 21 2.2 Thank you very much and have a nice day. 23 CHAIRPERSON MATHIS: Thank you. Our next speaker is Curtiss Leroy, and he is 24 25 representing PC226. The subject is civic justice.

1 MR. CURTISS LEROY: Good morning. My name is 2 Curtiss Leroy. I'm a PC in representing 226. I'd like to address the issue of civic justice, 3 4 more specifically the way in which the Commission has or in 5 this case has not exercised its civic responsibility in 6 selecting legal counsel. 7 You would think that given the bipartisan 8 Commission, two Democrat, two Republican, and an 9 Independent, and knowing there's only two selections to be 10 made, they would have chosen attorneys that each side had 11 indicated as their preference. 12 It just seemed like the natural outcome, but 13 Commission charged with the responsibility of all of 14 Arizona. You would think that after Vice Chairman Freeman 15 16 had stated that he was willing to give deference to accept 17 as Democratic counsel any of the three interviewees, so long 18 as he would be given the same deference and that his pick 19 for Republican counsel was Lisa Hunter(sic), that you would 20 think that the Democrats would have reciprocated. 21 That would seem like the natural outcome. 22 Unless there was an agenda to prevent the selection of Hunter. 23 24 You would think that after Commissioner Herrera 25 indicated his preference for Michael Mandell as counsel and

1	later voted him down when the vote was to select Hunter and
2	Mandell as the two representatives, you would think there
3	was some reason for this inconsistency.
4	It's just not the natural outcome for that
5	scenario.
6	And why would the Independent commissioner side
7	with the Democrats that are telling the Republicans that
8	they are choosing for them someone more qualified than Lisa
9	Hunter. By the way, Lisa Hunter served as a served the
10	Republicans in this capacity in the 2000 redistricting
11	effort. You would think that there was some concerted
12	effort here to prohibit the Republican selection.
13	You would think that it was a fatal flaw in this
14	supposedly bipartisan body.
15	I could go on, but the question here is this.
16	Will this be indicative or indicative of the votes
17	to come.
18	Commissioner McNulty has stated that she was
19	concerned that the public be proud of the process.
20	Well, the folks in Precinct 226 are watching, and,
21	Commissioner, we're not proud of the process.
22	Thank you.
23	CHAIRPERSON MATHIS: Thank you.
24	Next speaker is Frank Olivieri, representing
25	Precinct 148. And the topic is open process.

MR. FRANK OLIVIERI: Ladies and gentlemen, thank you for allowing me to speak this morning. I represent Precinct 148 in the unincorporated areas of Pima County.

Talk about the criteria for selecting a vendor open process. How transparent would the process for the mapping contract request proposal be and when will you publish the criteria for selecting a vendor, which includes objectives, project details, deliverables, just to name a few.

Since you'll be using the Arizona state procurement rules for the request for proposal, which is your official statement to vendors about the services you --services required, vendors typically try to respond point by point to your RFP when you make the proposals. For these reasons, the RFP must be carefully crafted and reviewed before distributing it to the vendors by the State.

Compensation for this successful vendor is derived from the taxpayer's pocket, and the public deserves transparency on how the dollars are spent and the vendor does not exceed the budget.

Finally, do the results meet the goals specified by the input from the respective communities, sometimes key communities like together of interest -- like interest together, respect local boundaries such as cities, counties, and schools, create compact and contiguous communities.

A typical RFP would include the following, but not limited to, number one, general goals. This section includes the general business goals which are met by the process.

2.2

Number two, the target audience. These are the citizens of the state of Arizona, they're ultimately paying for this, would their goals be heard openly and fairly.

Number three, objectives. Each objective should be listed and discussed openly and performed to state and federal regulations election laws that consider the public's goals.

Number four, project details. This selection -this section should include summaries of public meetings,
federal and state rules and regulations, descriptions and
anticipated project team reporting on the process,
description of required development process and division
cycles, listing of expected deliverables.

Number five, constraints on budget schedule and design. This section should describe. To stay within the budget boundaries, specific dates and completion of milestones such as design plans, drafts, test sessions of master deliverables, constraints on the process.

Number six, resources provided. This section should describe the resources, information, critical data, et cetera, to be provided by you and the public record.

1	Specifically it should include a description of the subject
2	matter experts, market research, technical documentation,
3	and any other resources that would provide the vendor going
4	forward with the process.
5	Number seven, criteria for evaluating success.
6	How will be public objectives be taken from the public
7	record be met. If so, how was it measured.
8	Number seven finally number seven, criteria for
9	selecting a vendor. This is a list of criteria which we use
LO	for determining best vendor proposal. Typical criteria
L1	include vendor quality as evidenced in the sample of the
L2	work, price, vendor's understanding of the subject matter,
L3	and so on.
L4	Thank you.
L5	CHAIRPERSON MATHIS: Thank you.
L6	Our next speaker is Geri Ottoboni. Excuse me,
L7	you'll have to correct that for me when you come up.
L8	She's representing NETOT, so you'll have to tell
L9	us what that is. Thanks.
20	MS. GERI OTTOBONI: I was having difficulty
21	hearing people in the back, so can people hear me?
22	CHAIRPERSON MATHIS: Can everyone hear okay?
23	MS. GERI OTTOBONI: Maybe it's too low, just
24	because I was having trouble hearing what Frank was saying.
25	CHAIRPERSON MATHIS: Okay

1 It's on. They just need to be on it. BUCK FORST: 2. MS. GERI OTTOBONI: Closer? Is that better? 3 CHAIRPERSON MATHIS: Yeah. 4 Okay. Because I had a MS. GERI OTTOBONI: 5 difficulty hearing all the individuals who spoke earlier. 6 I think there's only one person I could hear 7 clearly. 8 Anyway, Geri Ottoboni, and I live here in 9 Oro Valley. And I want to thank the Commission for having 10 the meeting in Oro Valley, but I am surprised and shocked 11 when I learned that the Oro Valley town council room had been booked last week. 12 13 And I was concerned because the e-mail 14 notification from the Arizona Redistricting Commission went 15 out barely 48 hours before the meeting was scheduled. 16 Redistricting is of such complexity and importance 17 to the public that it should require additional public 18 notice other than what's required by law, like 24, 48, and 19 even 72 hours' notice, often covering a holiday, like 20 Memorial Day was covered, because it was the day after 21 Memorial Day, or weekend, is insignificant -- insufficient, 2.2 I'm sorry, time to give the public time to participate. 23 I urge the Commission to let the public know 24 immediately when the location is booked so the maximum 25 number of people can participate.

1	And just to point of note, I've been up to Phoenix
2	twice, and it was interesting because there were very few
3	people in attendance.
4	So I thought this possibly might be the reason.
5	So thank you for much for your time.
6	CHAIRPERSON MATHIS: Thank you.
7	Next speaker is Christine Bauserman, and
8	representing Citizens for Common Serve Redistricting.
9	MS. CHRISTINE BAUSERMAN: Sense.
10	CHAIRPERSON MATHIS: Oh, sense. All right.
11	Common sense. I'm sorry.
12	I won't make a comment about myself on that one.
13	Subject is LD 30 boundaries Rita Ranch.
14	MS. CHRISTINE BAUSERMAN: I'm representing Ken
15	Moyes, M-O-Y-E-S.
16	He was on unable to attend on the way here. I'm
17	from LD 30, which is on the far northeast side, about an
18	hour from here.
19	RAY BLADINE: Use the mic.
20	MS. CHRISTINE BAUSERMAN: Is that better?
21	Ken Moyes is the former director and secretary of
22	the reed Rita Ranch Neighborhood Association, and he wanted
23	us to speak on elements of common community interest.
24	Rita Ranch neighborhood is chartered by the City
25	of Tucson to identify and encompass common communities

defined by a neighborhood of common interest. The boundaries of the association start at Foreman Road at the north, the city limits on the east, I-10 on the south, and with some jogs mostly the Harrison Road line extended south of the western boundary.

The long-standing large plain development known as Rita Ranch falls within the Rita Ranch Neighborhood Association and is bounded by Valencia, Houghton, and Old Vail Roads.

The following is a list of common interests with Legislative District 30 besides the neighborhood association with communities east of Houghton Road.

The first one is the school district. All developments along Houghton south of Irvington Road including Rita Ranch fall into the Vail school district.

The second is shopping. All -- Rita Ranch in that area contains the only shopping out there. So everybody south all the way east, everybody goes there shopping.

Employment, a high percentage of the neighborhood work at Raytheon, IBM, and DM Air Force Base.

Another is entertainment. The annual Rita Ranch Family Fun Day on Memorial Day weekend has 2,000 people attending, it's held in Purple Heart Park in the Rita Ranch development and it is attended by residents of both east and west side of Hallum all in the neighborhood association.

1	You know, it is the hub of that park is the hub.
2	Isolation. Rita Ranch is isolated and
3	noncontiguous both socially and physically to the north,
4	west, from the, from the other LD areas by vacant land and
5	the military base.
6	It's like here and the base is here.
7	The Houghton corridor is a transportation that
8	links all of LD 30 and Rita Ranch, links them to that
9	corridor. Again, that was part of transportation.
10	Thank you.
11	CHAIRPERSON MATHIS: Our next speaker is Tommy
12	Tucker, 2007, 2008, Pinal County rep community, and the
13	subject is the future.
14	MR. TOMMY TUCKER: Thank you again for coming.
15	And certainly can understand with the whole state
16	in mind that it's pretty hard to do your scheduling, and I
17	certainly understand that.
18	I try to sit in here wearing your moccasins as
19	much as possible.
20	Eleven minutes ago the Saddlebrook PC's meeting,
21	which is monthly, ended.
22	So I'm one of the few, I think maybe the only one,
23	here from there.
24	We live just a mile and a half above the two
25	county line.

And logistically these two HOAs, of which there are 31, I think the County is active precinct people, obviously for one party, but the other party has a similar kind of structure.

We do, like was mentioned earlier, we interact, we buy everything essentially here in Pima.

But when you only have two precincts that are connected with an area that you, you get with the people, but in theory you have no -- we have no input directly to Pima County.

By this, however, our nonlogistic people, they get more in tune with the political aspects of Pima, which you can't do anything about, than they do about Pinal.

And the thing that really bothers me as a past chair logistically is the fact that we have great trouble going over, yes, as we've mentioned earlier, near Florence, you know, Florence, everything's in Florence for us, in a county that's larger than three states.

So we had, as chair, Maricopa as an example in CD 7, and they have kind of a similar situation.

And if you go along, there's Eloy, which is close, Coolidge. And it would appear that as redistricting boundaries might be done, that if we take and have a line, artificially of course, that runs essentially across that southern part so that it combines to a degree, you can then

have structure, whether -- whatever party it is. Where those areas interact with the area that is to the south without losing their identities.

2.

And so in doing that, it would seem to be more structurally, for whatever that next CD, eight or whatever it might be, we don't know what the number is going to end up with obviously, but it seemed to make a lot of sense.

I think everybody on the Commission is aware that nine, at least the scuttlebutt, that the new nine will kind of center in Casa Grande.

And whether that's true or not, we don't know, but obviously there's quite a little issue here.

But you can have, whether you're Democrats or whether you're Republicans, you can have organizations that at least have continuity for their respective areas. And we wouldn't lose that identity with Pima, yet we would not have -- our people have so much trouble to realize all our -- everything that the county does to us is over there in Florence.

It's not down here in Tucson.

So that is what I call the future. And I know that there are all kinds of numbers that are going to enter into this whole picture.

But I think for a better state, as many -- we have other, you know, all across the state we have this type of

1 thing. And I realize that's rough for you people, because 2. putting it all together is kind of tough. But thank you for being here. 3 4 CHAIRPERSON MATHIS: Thank you. Our next speaker is James Kelley, chairman of 5 Legislative District 29 GOP, representing Pima GOP, and 6 7 subject is mapping. 8 MR. JAMES KELLEY: Here we go. Good morning. 9 Thank you for my time today. 10 CHAIRPERSON MATHIS: Good morning. 11 MR. JAMES KELLEY: With regardS to Legislative 12 District 29, it is my sincere desire that our boundaries 13 change dramatically. 14 At the moment the transportation corridors, the 15 communities of interest, actually compete against each 16 other. 17 My precinct in 296 is extremely diverse 18 culturally, including Pan-Asian, Pan-African, and 19 Pan-American citizens. And the culture just doesn't really 20 matter. We all consider ourselves members of 21 Rancho Valencia. 2.2 We have much more in common with Rita Ranch than 23 we do with downtown Tucson. 24 What I would like is I would like our borders, our 25 west borders to move east to Campbell. I would like our

1	northern borders to move all the way to Broadway. And I
2	would like our eastern borders to move all the way to
3	Houghton, to include Rita Ranch.
4	They were gerrymandered out into 30 ten years ago,
5	and basically took away homeowners, people of interest that
6	have more in common with the communities within the
7	boundaries that I just named.
8	We have more homeowners west of Campbell than we
9	do east of Campbell.
10	At our interest in terms of economic interest,
11	Raytheon, again, most of the people in my district west of
12	Campbell work for Raytheon or contractors that feed
13	Raytheon, or the airport, which is an area of interest.
14	Again, that is now in 30, but they live in 29.
15	So, all of these different areas that got
16	gerrymandered ten years ago has hurt my district
17	tremendously.
18	We're always at odds.
19	And that downtown centric controls what happens
20	everything east of Campbell.
21	So, that is my request for mapping. Those are the
22	boundaries I request for LD 29.
23	Thank you very much.
24	CHAIRPERSON MATHIS: Thank you.
25	Our next speaker is Chayah Masters, a member of

the Smart Girl Politics and a local realtor, and her subject
is redistricting.

MS. CHAYAH MASTERS: Thanks so much for -- I think that's, I think that's too low for me. But, anyway, all right, can you hear me?

CHAIRPERSON MATHIS: Yes.

2.2

MS. CHAYAH MASTERS: Basically I'm not going to take too much time. I just wanted to pretty much reaffirm what the gentleman from the Tea Party mentioned about the fact that as a local realtor -- thank you -- thank you.

As a local realtor with Saddlebrook, and, you know, I'm on the front line seeing the people that move into our state, and one of the major populations that comes in as I'm sure everybody knows here is the retirees.

One of their -- whether -- it doesn't matter what party they're in. One of their primary social outlets has to do with their political involvement. And by keeping like minded communities -- or not like minded, but like communities together, it allows them to participate, stay engaged, and feel like they're, you know, involved in the community and whatnot.

And as well as, you know, I would hope the lines don't change too much, because it is a very dynamic group down here, and so I just wanted to kind of jump on what he said and reaffirm that.

1	Thank you.
2	CHAIRPERSON MATHIS: Thank you.
3	And our last speaker is Joyce Schulte, owner of
4	Copper Creek Cookies.
5	And the subject is allow more time for citizens to
6	respond.
7	MS. JOYCE SCHULTE: Good morning to you all.
8	This is I'm a little short. In fact, I'm
9	shrinking.
10	Good morning. I have to tell you this very
11	impromptu, so I'm just going to speak from what I know.
12	I went home this morning. I was in a meeting at
13	Raytheon at 8:00 o'clock. I went home, clicked on my
14	computer, because I just live up the street, that they're
15	having a meeting at the town hall.
16	So I said, okay, I'm going to go. I was talking
17	to my daughter-in-law, and I hung up.
18	I do live in LD 26.
19	And my word to you, all of you, is, if it ain't
20	broken, don't try to fix it.
21	And this is, this is a good district.
22	Everything's going smoothly, we love our representatives,
23	and we're just glad you came today so we could tell you how
24	great this is.
25	Thank you very much.

1	CHAIRPERSON MATHIS: Thank you.
2	COMMISSIONER STERTZ: Thanks.
3	CHAIRPERSON MATHIS: Is there anyone else from the
4	public who would like to address the Commission today?
5	I'm out of slips.
6	(No oral response.)
7	CHAIRPERSON MATHIS: Last call.
8	(No oral response.)
9	CHAIRPERSON MATHIS: That will conclude our public
10	comment then.
11	And thanks everyone for your input.
12	Our next topic agenda item is executive director's
13	report, and so Ray Bladine will come and give us a report on
14	preparations for public hearings, agency staffing needs, and
15	other items related to office operations.
16	So, Ray, when you're ready.
17	RAY BLADINE: Thank you, Madam Chair. I will be
18	brief but cover some of the items that you mentioned.
19	We are in the process of beginning the first phase
20	of staffing up the public hearings that will be coming along
21	in July.
22	We also are receiving applications for a public
23	information officer. Someone was nice enough to post us on
24	the web page of the Public Information Officer Association,
25	so within the last several days I've got seven or eight

1 resumes of people that have experience in it. 2. My thought is I'll get them all in a package and 3 then get them out to you to take a look at. 4 The outreach staffing is something that we're 5 starting to work on now, because we know once you start 6 public hearings it will be important to have people to be 7 available at the various locations that we're planning to 8 have. 9 We will hopefully by next week have a memo to 10 present to you to take a look and see if it will meet your 11 public information and public hearing desires. We have had some initial contacts with 12 organizations such as the League of Arizona Cities and 13 14 Towns, which led us to today's facility, but I've had some 15 information from the Community College Districts, and we 16 will follow up with them. Ideally we'd like to find locations where there 17 18 already is an ability for us to hook up to the Internet so 19 we can provide the streaming. 20 Just to clarify, I had a couple questions last 21 week. 22 Our appropriation for this fiscal year was 23 \$500,000. 24 For next fiscal year, it's three million. 25 Unlike other state departments, that 500,000

1 carries over. 2. So right now the total amount that we have for your work that's appropriated is three and a half million. 3 4 I'm going to be meeting next, probably later this 5 week, with our budget support person to really try to pull 6 together a budget based upon what we know now. 7 I will tell you that last year it appeared -- not 8 last year, ten years ago, that this is about the same amount 9 of money they had for the first full year. It, of course, 10 went up with litigation. 11 So I guess my point to you would be it looks like 12 we have sufficient appropriation to do our job, and I'll get 13 you more information on that. 14 We finally have a copier in the office so we can 15 now make copies and be ready to send things out. 16 We also took possession of the records of the 17 Commission ten years ago, which was 70 boxes of information that the Secretary of State's Office of nice enough to send 18 19 staff over to carry up two flights of stairs in the Evans 20 House. 21 And thanks to my assistant, Kristina Gomez, I was 22 also enlisted to carry boxes and was happy to find that I 23 could do that. 24 It made me feel good that I was young.

Finally I had a meeting this week with Ken Clark

25

of the Competitiveness Coalition, who's asked to be on one of your future agendas.

The information I thought you'd find interesting is that their competition of maps that they are asking people to submit before, in quotes, winners that they will select, and those four maps, two students, two adults, will be submitted to you for your record.

He also said he would be most happy to hand over any of the other documentation or maps that are submitted to them so they can be part of our record, and they would have no problem with us continuing that web page if we would desire so that people could have their only ability to play around with mapping.

I think those are the main things I wanted to share with you, but I would be most happy to answer any questions you might have.

CHAIRPERSON MATHIS: Thank you, Ray.

Any questions for Mr. Bladine?

VICE CHAIR FREEMAN: Madam Chair, Mr. Bladine, just to be clear, you expect that at our next hearing you'll be able to present us with a budget that we can look at.

RAY BLADINE: Yes, I believe about the best I'm going to be able to do is take a look at what they did last year, take what information is available in terms of what we spent to date, and try to lay something out so that we can

1 have some idea by subcategories.

2.

2.2

Right now we just have the overall appropriation.

I do have the detailed expenditures from ten years ago, so I think I should be able to pull something together via pretty reasonable estimate for us to look at.

VICE CHAIR FREEMAN: And another question on the documents from the last IRC, did those documents, those records include records of executive session hearings conducted last time and sessions where the commission was getting legal advice with respect to the litigation?

RAY BLADINE: I believe they do.

We have indexed them, and Kristina is nodding. She put information together last time, so, yes, they're there.

That, of course, would still have to be held confidential.

Since the material was submitted to the state archives, and then under their jurisdiction I had to sign away of form that if I were going to have anymore children they would get the first one, but I don't, but basically says we need to protect them, we need to keep track of where the records are, we have to test for bugs, and they have to be six inches off the ground.

So the bottom line is that we will really have to be careful about any public access to them and treat them as

1	if they were in the archives.
2	VICE CHAIR FREEMAN: Thank you.
3	VICE CHAIR HERRERA: Madam Chair.
4	CHAIRPERSON MATHIS: Mr. Herrera.
5	VICE CHAIR HERRERA: What was the purpose of
6	bringing those boxes to the Evans House?
7	RAY BLADINE: Primarily, Commissioner Herrera, I
8	think one of the advantages I think that we have over the
9	last Commission is that there was a last commission that we
10	can go back and see what they did and what worked and what
11	didn't work, and it makes it much more available for our
12	legal team to take a look at what happened in terms of legal
13	challenges and also the recordkeeping.
14	So we see it as a way that we can benefit from the
15	past to do a better job in the future.
16	VICE CHAIR HERRERA: Thank you.
17	COMMISSIONER STERTZ: Madam Chair.
18	CHAIRPERSON MATHIS: Mr. Stertz.
19	VICE CHAIR HERRERA: Mr. Bladine, is it your
20	anticipation that we are going to be publishing an overall
21	public meeting schedule including locations at one time?
22	RAY BLADINE: Yes, there is.
23	COMMISSIONER STERTZ: And what is the anticipated
24	date of the first draft of that or the second draft of that
25	coming out?

1 RAY BLADINE: I would hope that perhaps by the end 2 of next week. I -- we've been receiving some comments from 3 all of you. I would like to get some more. 4 I would also like to make sure we contact possible locations before we, you know, talk about them in public. 5 6 But I'd like to have a public discussion with you 7 on that, so that, just as you're saying, there would be 8 ample lead time for people to know where we'll be taking 9 testimony in the month of July. 10 COMMISSIONER STERTZ: And the anticipation is that 11 the testimony, if we are going to be live streaming, will there be an ability to collect commentary from locations 12 13 where it would be live streamed to? 14 Our plans to live stream and RAY BLADINE: Yes. 15 also have hookups by Skype, probably the first time two 16 other locations than the original location. We would have staff at each of those locations 17 18 that could serve as kind of a host capacity to accept 19 comment cards, to schedule that location, to comment to the 20 overall meeting. 21 So we're trying to utilize a technology as much as 22 we can to have as many sites available to the public in a 23 given geographic area at one time. 24 So, yes, we are, we are hoping that technology 25 will be on our side and not be an enemy right now, but it

1 looks to me like we're getting the bugs worked out and it 2. should work well for us. COMMISSIONER STERTZ: As a matter of ease of 3 4 public having access, right now the -- we have no -- none of 5 our activity is interact -- in other words, we're not 6 posting anything on any social media sites. 7 No, sir. RAY BLADINE: 8 COMMISSIONER STERTZ: So, is there an anticipation 9 that we're going to get Facebook or some sort of other 10 social media for the posting of these and then linking 11 previous hearing video to those sites? 12 RAY BLADINE: We intend to have the public 13 information officer to really explore that once we have one 14 on board. 15 It certainly is something that seems like could 16 work for us. 17 We have been put on alert that there are some 18 information problems with public agencies in doing that. 19 We know there's training out there. So one of the 20 first thing we do is to get our staff trained. 21 But I think the way I read the intention of the 2.2 Commission sometime ago was to take a look at that as being 23 a possibility for having better community outreach and 24 information available all the time. 25 COMMISSIONER STERTZ: Perfect. Thank you.

1	CHAIRPERSON MATHIS: Other questions?
2	(No oral response.)
3	CHAIRPERSON MATHIS: Mr. Bladine, thank you.
4	RAY BLADINE: Thank you.
5	CHAIRPERSON MATHIS: That takes us to agenda item
6	four, discussion and consideration of confidential documents
7	associated with the evaluation of responses to the mapping
8	consultant RFP and ranking of submitted proposals.
9	Just a brief recap.
10	Our request for proposal for mapping services went
11	out through State Procurement. It was on the street, so to
12	speak, for a little over two weeks. And it closed on
13	June 9th at 3:00 p.m.
14	And at that point State Procurement opened up the
15	bid, and we saw that there were seven responders to that
16	RFP, which was great. You never know how many will come
17	across the transom, so to speak.
18	So we were glad to have the response.
19	And I think we have State Procurement here today,
20	somewhere. They're not in the room at the moment. They're
21	in the back.
22	I don't know if commissioners have any comments
23	regarding the proposals that they want to mention in public
24	session.
25	Those proposals, those responders, what they

11	to ask Jean Clark, the administrator for State Procurement,

18	seven responses to the mapping consultant RFP.
19	Based upon our initial evaluation of all seven of
20	those responses, it's recommended at this time that four
21	firms, in no particular order here, be progressed forward to
22	possibly hold interviews and discussions and clarifications
23	with us.
24	And those four firms are Strategic Telemetry,
25	National Demographics, Research Advisory Services, and Terra

1	Systems Southwest.
2	CHAIRPERSON MATHIS: Great. Thank you.
3	Any discussion from any commissioners?
4	(No oral response.)
5	CHAIRPERSON MATHIS: Without objection, I suggest
6	we proceed with interviewing those four firms. And, so give
7	you an opportunity.
8	Any comments?
9	(No oral response.)
10	CHAIRPERSON MATHIS: Okay. So we will rely upon
11	the State Procurement Office, Jean, to contact those four
12	firms and set up interviews.
13	We should probably discuss the format of those
14	interviews, how we would like to proceed.
15	Does anyone have any initial thoughts?
16	COMMISSIONER STERTZ: Madam Chair.
17	CHAIRPERSON MATHIS: Yes, Mr. Stertz.
18	COMMISSIONER STERTZ: Recommendation would be that
19	we tentatively set aside the 24th of June for an opening for
20	us to be able to have interviews done at a location yet to
21	be determined in Phoenix.
22	My recommendation would be that we would do a
23	morning session of two interviews and an afternoon session
24	of two interviews, leaving sufficient time between those
25	interviews for recap and consultation and note taking.

1	My recommendation would be that we assign the
2	times based on random order or availability as selected
3	after SPO contacts the proposers, and that we set a time of
4	no less than one hour, no more than one and a half hours,
5	for the interview process.
6	CHAIRPERSON MATHIS: Any comments from other
7	commissioners on Mr. Stertz' recommendation?
8	VICE CHAIR HERRERA: Madam Chair.
9	CHAIRPERSON MATHIS: Mr. Herrera.
10	VICE CHAIR HERRERA: As we did previously, I
11	suggest that we allow the public comment before and after.
12	I think that was helpful.
13	CHAIRPERSON MATHIS: Good suggestion.
14	Any other thoughts?
15	COMMISSIONER McNULTY: Should we standardize
16	whether they how long we have questions, whether they
17	make an opening statement, whether they actually make some
18	sort of demonstration, presentation, software that they
19	might use, and how much time we reserve for questions, so
20	they have a better sense of how long to make their
21	presentation?
22	COMMISSIONER STERTZ: Madam Chair.
23	CHAIRPERSON MATHIS: Commissioner Stertz.
24	COMMISSIONER STERTZ: I agree completely. I think
25	I would like to reserve a component of the time for

1 presentation of their mapping system that they're be using, 2 but I prefer to have the majority of the time for question It was a one third, two third of the allotted 3 and answer. 4 time I think, it seems to make sense, I think a 5 recommendation for an opening statement or presentation, but 6 I would like to reserve at least one third of the overall 7 allotted time for Q and A. 8 CHAIRPERSON MATHIS: Other thoughts? 9 COMMISSIONER McNULTY: I agree with that and maybe 10 even more time for Q and A. 11 COMMISSIONER STERTZ: From two thirds to three 12 quarters of the time. 13 CHAIRPERSON MATHIS: Frankly I'm in favor of 14 leaving it somewhat open in terms of just giving them 15 maximum flexibility to present what they want to present, 16 not necessarily having do a demo, if that's how they choose 17 to use their time. 18 So I don't know how much constraint we want to put 19 on them. 20 COMMISSIONER McNULTY: I agree with that. I don't 21 think we're going to get too much out of looking at the 22 mapping software itself, because this is what they've 23 designed. So I would agree with that. It probably isn't 24 something that we need to encourage. 25 Madam Chair, COMMISSIONER STERTZ:
