If it is necessary to recess the October 10, 2001 meeting, the Commission will hold a resumed public meeting on October 11, 2001. If it is necessary to recess the October 11, 2001 meeting, the Commission will hold a resumed public meeting on October 12, 2001. If it is necessary to recess the October 12, 2001 meeting, the Commission will hold a resumed public meeting on October 13, 2001. If it is necessary to recess the October 13, 2001 meeting, the Commission will hold a resumed public meeting on October 14, 2001. These regular and resumed meetings will be held beginning at 8:30 a.m. on October 8, at 8:00 a.m. on October 9

and, if necessary, beginning at no earlier than 8:30 a.m. on October 10-14. All of the foregoing meetings will be held at The Sheraton Phoenix Airport, 1600 S. 52<sup>nd</sup> Street, Tempe, Arizona.

The Commission may vote to go into executive session, which will not be open to the public, for any item listed on the agenda, for the purpose of discussing personnel matters (A.R.S. §38-431.03(A)(1)), consulting with Commission attorneys, regarding pending or contemplated litigation (A.R.S. §38-431.03(A)(4)), or obtaining legal advice (A.R.S. §38-431.03(A)(3)).

The agenda for these regular and resumed meetings is as follows:

- I. Call to Order (and at the beginning of each regular or resumed public meeting).
- II. Presentation by Pat Dunbar to complete public service orientation for Commissioners Lynn, Elder and Hall. **NOTE: This agenda item will be considered only during the Commission's resumed meeting on October 9, 2001, from 8:00 a.m. until 10:00 a.m.**
- III. Public Comment (and at the beginning of each regular or resumed public meeting **but no earlier than 10:00 a.m. on Tuesday, October 9, 2001**).

This is the time for consideration and discussion of comments and complaints from the public. Those wishing to address the Commission shall request permission in advance by filling out a speaker slip. Action taken as a result of public comment will be limited to directing staff to study the matter or rescheduling the matter for further consideration and decision at a later date unless it is the subject of an item already on the agenda.

NOTE: The Commission may hold additional public comment periods throughout these regular and resumed public meetings on the call of the Chairman as necessary and appropriate to accommodate the public.

- IV. Possible presentation(s) by NDC and legal counsel, discussion(s) and possible decision(s) concerning alternatives and changes to the draft congressional and legislative districts and the development and adoption of final congressional and legislative district maps.
- V. The Commission may vote at any time to go into an Executive session that is not open to the public for the purpose of discussion or consultation for legal advice with the Commission's attorneys pursuant to A.R.S. §38-431.03(A)(3) and for the purpose of discussion or consultation with the Commission's attorneys in order to consider its position and instruct its attorneys regarding the Commission's position in pending or contemplated litigation pursuant to A.R.S. §38-431.03(A)(4).
- VI. Public Comment. (Same guidelines as stated in agenda item II).
- VII. Discussion of possible public comment period and future Commission Meeting(s).
- VIII. Recess or Adjournment.

**NOTICE is hereby given that the Commission meeting may be recessed in public session on October 9, 10, 11, 12, or 13, 2001, to be resumed on the mornings of October 10, 11, 12, 13 or 14, 2001, at the times and locations set forth herein. Before recessing, the**
