Pursuant to Article IV, Part 2, § (12) of the Arizona Constitution and A.R.S. §38-431.02, notice is hereby given to the Commissioners of the Arizona Independent Redistricting Commission and the general public that the Arizona Independent Redistricting Commission will hold a meeting, open to the public on July 6, 2001. This meeting will be held at 8:00 a.m. at the State Capitol Executive Tower, 1700 West Washington, Governor's Reception Room, 2<sup>nd</sup> Floor, Phoenix, Arizona.

The Commission may vote to go into executive session, which will not be open to the public, for any item listed on the agenda, for the purpose of discussing personnel matters (A.R.S. §38-431.03(A)(1)), consulting with Commission attorneys regarding pending or contemplated litigation (A.R.S. §38-431.03(A)(4)), or obtaining legal advice (A.R.S. §38-431.03(A)(3)).


The agenda for the meeting is as follows:

- I. Call to Order.
- II. Public Comment.

This is the time for consideration and discussion of comments and complaints from the public. Those wishing to address the Commission shall request permission in advance by filling out a speaker slip. Action taken as a result of public comment will be limited to directing staff to study the matter or rescheduling the matter for further consideration and decision at a later date.

- III. Presentation, discussion and possible decision with respect to the operational implications of citizen input and the development of the AURs (Arizona Units of Representation) for each area of the state.
- IV. Presentation, discussion and possible decision with respect to the process and schedule for development of draft congressional and legislative maps, the 30-day public comment period, the second round of public hearings and adoption of the final congressional and legislative maps.
- V. Executive Director's Report
  - A. Recap of first Round of Public Hearings
  - B. Presentation by Outreach Coordinator, discussion and possible decision concerning plans through the development of draft congressional and legislative maps, the 30-day public comment period, the second round of public hearings and adoption of the final congressional and legislative maps.
  - C. Presentation by Public Information Officer, discussion and possible decision concerning plans through the development of draft congressional and legislative maps, the 30-day public comment period, the second round of public hearings and adoption of the final congressional and legislative maps.
- VI. Discussion or consideration and possible decision concerning acceptance of resignation of Executive Director. The Commission may vote to discuss this matter and/or obtain legal advice from the Commission's attorneys in executive session pursuant to A.R.S. §38-431.03(A)(1), (3).
- VII. Possible discussion, consideration and/or decision concerning selection of new Executive Director. The Commission may vote to discuss this matter and/or obtain legal advice from the Commission's attorneys in executive session pursuant to A.R.S. §38-431.03(A)(1), (3).
- VIII. Executive session for discussion or consultation for legal advice with the Commission attorneys pursuant to A.R.S. §38-431.03(3).
- IX. Public Comment (Same guidelines as stated in agenda item II).
- X. Adjournment.
