Notice is hereby given to the members of the Arizona Independent Redistricting Commission and to the general public that the Commission will hold meetings open to the public at the times and location listed below for the purpose of hearing Citizen Comments and discussing and acting on the items listed below:

The Commission may vote to go into executive session, which will not be open to the public, for any item listed on the agenda, for the purpose of obtaining legal advice (A.R.S. §38-431.03 (A) (3) and (4)). One or more of the members may participate via telephone or video conferencing.

**All matters on the agenda may be discussed, considered and are subject to action by the Commission.**

The agenda for the meeting is as follows:

- I. Call to Order.
- II. Report regarding voting rights analysis of proposed legislative and congressional districts,
- III. Discussion, direction to mapping consultant and possible action regarding adjustments to the approved Final Tentative Legislative Districts Map to address technical or legal issues. The Commission may vote to go into executive session, which will not be open to the public, for the purpose of obtaining legal advice and providing direction to counsel regarding mapping legal issues (A.R.S. §38-431.03 (A) (3) and (4)). (Estimated Time 120 minutes)

- IV. Discussion, direction to mapping consultant and possible action regarding adjustments to the approved Tentative Final Congressional Districts Map to address technical or legal issues. The Commission may vote to go into executive session, which will not be open to the public, for the purpose of obtaining legal advice and providing direction to counsel regarding mapping legal issues (A.R.S. §38-431.03 (A) (3) and (4)). (Estimated Time 60 minutes)
- V. Discussion and possible action regarding renumbering the Congressional and/or Legislative districts. Discussion and possible action to adopt and certify final Legislative and/or Congressional districts. (Estimated Time 30 minutes)
- VI. Review discussion and possible authorization for staff to request a supplemental appropriation for fiscal year 2012 (Estimated Time 30 minutes)
- VII. The Executive Director will summarize recent staff activities and respond to Commissioners' questions. (Estimated Time 20 minutes)
- VIII. Review and discussion of possible future agenda items and meetings. (Estimated Time 15 minutes)
- IX. Call for Public Comment. This is the time for the public to comment on items on the agenda or redistricting maps. Members of the Commission may not discuss items that are not specifically identified on the agenda. Therefore, pursuant to A.R.S. § 38-431.01(H), action taken as a result of public comment on matters not on the agenda will be limited to directing staff to study the matter, responding to any criticism or scheduling the matter for further consideration and decision at a later date. (Estimated Time 30 minutes).
- X. Adjournment.
