Pursuant to Article IV, Part 2, § (12) of the Arizona Constitution and A.R.S. §38-431.02, notice is hereby given to the Commissioners of the Arizona Independent Redistricting Commission and the general public that the Arizona Independent Redistricting Commission will hold a meeting open to the public on March 1, 2004, at 9:00 a.m. at the Sheraton Phoenix Airport, 1600 S. 52nd Street, Tempe, Arizona.

NOTE: All matters on the agenda may be presented, discussed and/or are subject to possible decision by the Commission in person or electronically.

The agenda is as follows:

This is the time for consideration and discussion of comments and complaints from the public. Those wishing to address the Commission shall request permission in advance by filling out a speaker slip. Action taken as a result of public comment will be limited to directing staff to study the matter or rescheduling the matter for further consideration and decision at a later date unless it is the subject of an item already on the agenda.

NOTE: The Commission may hold additional public comment periods during this public meeting on the call of the Chairman as necessary and appropriate to accommodate the public.

The Commission may vote to go into one or more executive sessions, which will not be open to the public, for any item listed on the agenda, for the purpose of discussion or consultation for legal advice with the Commission's attorneys pursuant to A.R.S. §38-431.03(A)(3) and/or for the purpose of discussion or consultation with the Commission's attorneys in order to consider its position and instruct its attorneys regarding the Commission's position in pending or contemplated litigation pursuant to A.R.S. §38-431.03(A)(4).
- V. Possible presentation(s), discussion(s) and decision(s) concerning additions or corrections to the record concerning the development of the February 23 legislative map.
- VI. Possible presentation(s), discussion(s) and decision(s) concerning adjustments to the February 23 legislative map including, but not limited to, adjustments in response to public comment, to cure traps between congressional and legislative district boundaries or to equalize population.
- VII. Possible presentation(s), discussion(s) and decision(s) concerning adoption of a legislative redistricting plan for presentation to Judge Fields on March 5, 2004, pursuant to his January 16, 2004 order in CV 2002-004380.
