Schwartz currently heads up the Community Relations practice for the firm Goodman Schwartz Public Affairs. Since the firm's inception more than 10 years ago, Schwartz has led numerous community outreach, coalition building and grass-roots mobilization efforts throughout the Greater Phoenix Metropolitan Region. He has also overseen or directly facilitated numerous community input processes necessary in a comprehensive and multidisciplined approach to public affairs. Prior to establishing Goodman Schwartz Public Affairs, Schwartz earned his "public affairs stripes" over the seven years he worked for then-Councilman Skip Rimsza as Council Assistant, and later as Deputy Chief of Staff when Rimsza became Mayor of Phoenix. In that capacity, Schwartz represented the Mayor's interests with local, regional and state government organizations. He designed and implemented all aspects of the Mayor's community outreach efforts.
